BSB Strategy 2023-25


October 2023 announced begun its own research to understand how technology is used at the Bar and what opportunities and risks it presents.

QAA BENCHMARK REVISION 2023

"As artificial intelligence tools and software evolve, **the role of human lawyers in decision-making and processes will change**. Providers may explore emerging models in the delivery of legal services in a digital society and the emerging and potential ethical issues involved. This can incorporate the use of digital justice, extend **the frontiers of artificial intelligence in legal reasoning**, and advance continuing professional development in the development of digital skills and technology." (Para 1.18)

UNCHARTED WATERS

- QAA Statement does not set required content for the Law degree.
- The last comprehensive, collaborative review of legal education was the Legal Education and Training Review 2013.
- Independent SRA and BSB education and qualification reforms have so far not addressed issues arising from AI.
